**Original Narrative**

On or about December 2022, Agents with Jones County Narcotics Division met with a credible confidential informant that has been proven creditable in the past by providing information, independently verified, leading to the arrest and prosecution of drug offenders in the Jones County area. That stated the he/she could purchase meth and pills from a guy in Jones County. At that time, agents had the C.I. attempt to set up a controlled narcotics purchase. The informant was issued a sum of county funds to purchase predetermined amount of fentanyl pills and methamphetamine. The informant went to meet with the suspect to purchase the narcotics. The suspect advised he did not have the drugs on hand, that the informant would have to drive him to 182 Houston Road to purchase them. Upon arriving at the address on Houston Road, the suspect exited the vehicle and went into the residence. The suspect returned with the predetermined amount of narcotics, and handed it to the informant. The informant then left and met with Narcotics Agents, where the drugs were turned over, and secured at the sheriff's office.

On the 2<sup>nd</sup> day of December 2022, Agents with Jones County Narcotics Division conducted surveillance on 182 Houston Road, Laurel, MS. During the surveillance Agents witnessed two vehicles arrive at the address, both vehicles had an occupant exit his/her vehicle and go inside the residence, only to come back out and leave within minutes of their arrival.

On the 2<sup>nd</sup> day of December 2022, Agents with Jones County Narcotics Division executed a search warrant at 182 Houston Road. Upon entering the residence, a black female, Jalesia Haynes, was standing in the living room. She was taken into custody. A black male, Patrick Francis, was in the bathroom, where he was taken into custody. Mrs. Haynes stated her son was about to get off the bus, at 182 Houston Road, and asked if she could call someone to come and get him.

Agents began searching the residence. Agent Joel Brogan located a large baggie of marijuana, digital scales, baggies for selling narcotics, a Glock 22 serial number BKWE503, and 106 suspected fentanyl pills in the cabinet in the kitchen area. Agents Chase Smith and Andrew Yates began searching the master bedroom. Agent Smith located a Kel Tec Rifle serial number FJT03 behind the closet door in the master bedroom, a Ruger 9MM serial number 331-22896 on the window seal in the master bedroom, a Tec-9 serial number 57617 in the closet, a Taurus 22 serial number 1PT377732 also in the closet, and \$2000.00 in cash in a box in the top of the closet. Agent Yates located a large bag of marijuana on the dresser in the master bedroom. Agent Driskell located \$1000.00 in the black Dodge Challenger parked in the driveway, and \$1030 in cash on Mr. Francis' person. Agents also located a stolen Polaris Sportsman, Vin number 4XASXM956JB136513. It was stolen out of Harrison County. D&H Towing recovered the Polaris. Agents also seized a black 2012 Dodge Challenger, Vin number 2C3CDYJC3CH193639.

Patrick Francis was transported to Jones County Adult Detention Center, where he was booked and processed. Jalesia Haynes was released. The evidence was seized and transported to Jones County Sheriff's Office, where it was logged and secured in the evidence room drop box. The Polaris was taken to B&H Towing Yard. The Dodge Challenger was transported to Jones County Sheriff's Department Training Center, where it was secured in the seizure lot.

Supplement #1 Narrative

On December 2nd, 2022 approximately 14:23 hours Agents with the JCSO narcotics division executed a search warrant at 182 Houston Rd. Agents conducted the search warrant where Agents recovered a stolen Polaris ATV along with a sum of fentanyl pills. Agents also recovered numerous firearms from the residence, and a sum of money. Agents had also received information from an agent with the Mississippi Bureau of Narcotics that a black male who drove a dark-colored Dodge Challenger had been involved with Patrick Francis in his illegal drug activity. Agents had conducted surveillance on 182 Houston Rd. on multiple occasions, and observed a black male in a dark-colored Dodge Challenger pull in and out of the driveway at 182 Houston Rd. Agents had also sent a picture of that black male driving the Challenger to an MBN Agent. The Agent stated he believed that it was the subject who drove the Challenger, that he knew to be involved with Patrick Francis. While the search was being executed at 182 Houston Rd. Agents also began to secure, the residence at 4737 University Avenue to get a search warrant after observing that the dark-colored Dodge Challenger was parked behind the residence, Agents approached the residence, and walked past the Challenger that had dark tinted windows, and was very hard to see inside. Agent Yates stood at the back door of the residence, and announced himself multiple times along with Agent Smith. Agents repeatedly called out if anyone was at the residence to make your presence known, after a few moments Agent Yates heard a voice behind him make an inaudible remark. Something to the nature of "why the fuck y'all in my yard." Agents had been standing facing into the back door of the house, with their backs to the car and announcing themselves for a few moments at that time. Agent Yates then observed a black male later identified as Deshon Bayless DOB-1/07/1995 sitting in the Challenger. Agent Yates gave Bayless commands to show his hands, and exit the vehicle. Bayless continued to mumble some kind of comments toward Agent Yates. Bayless finally exited the vehicle, and Agent Yates physically placed him on the ground due to the fact that Yates had no idea if there were weapons in the vehicle or what intent Bayless may have had toward Agent Yates, and his fellow Agents. Bayless was then placed under arrest for disorderly conduct failure to comply. Agents then searched the residence at 4737 Houston Rd. Bayless was then transported to the Jones County jail, and booked in on his charge. End report Jones 51
